Code Enforcement is Vital to Community Development

A Code Enforcement Officer is an inspector, officer or investigator, whose primary duties are the prevention, detection, investigation, and enforcement of violations of laws regulating public health, public convenience, comfort, prosperity, building standards, or general welfare as it pertains to areas, premises and buildings used for residential, commercial, industrial, travel, and public purposes. Code Enforcement is a function local governments perform that citizens consider important for accomplishing community goals, such as protecting property values and the environment.

When used in the context of Community Development, the term pertains to property upkeep and standards for new construction. Bringing property owners into compliance with Property Maintenance Codes, Zoning Resolutions, Building Standards, Health Codes and other ordinances can be an important part of maintaining the appearance, functioning, and property values of a neighborhood. New Property Maintenance Codes were adopted by Copley Township Trustees on December 12, 2016 and have been in effect as of January 2, 2017. The newly adopted codes can be viewed online by visiting Copley Township's website www.copley.oh.us.

Spring Cleaning

Is right around the corner; please keep in mind that it is a violation to have unsightly debris, or junk in your yard or around your property. Properties are expected to be kept free and clear of all weeds, or cut all such weeds and vegetation on land so they do not exceed eight (8) inches or more in length. Fallen leaves, branches, diseased plants, etc. should be collected and properly disposed of.

All buildings, and the exterior of all premises should be properly maintained so as to achieve an appearance characteristic to the neighborhood and to avoid blighted effects and hazardous conditions.

Copley Community Park Sports Fields - House Bill 143

The park has two baseball fields and three soccer fields that are reserved for organized youth play by local youth sports teams throughout the spring, summer, and fall. In addition, there is another soccer field located on Sunset Drive by the Police Department. The baseball fields were designed to accommodate both younger and older teams with bases that can be lengthened or shortened for whichever league may be playing. The pitcher's rubbers, however, are set in place and are not adjustable. Ball Field 1 (closest to the north parking lot) is designed for Bronco League and Pony League play. Pitching rubber is 52' from home plate and the bases adjust from 70' (Bronco) to 80' (Pony). Ballfield 2 is designed for smaller players in the Little League and Bronco League. The pitching rubber is 48' from home plate and the bases adjust from 60' (Little League) and 70' (Bronco). Fields may be reserved Mondays through Saturdays but no reservations are accepted for Sundays. The Trustees want the fields open one day per week so residents have a chance to use them. In 2013, the General Assembly of the State of Ohio passed House Bill 143 (HB143) that required all sports team managers, coaches, and referees to undergo training by the Ohio Department of Health (ODH) in concussion protocol. This was enacted for the safety of players because of the numerous cases of concussions that were occurring with some going unreported. Players were sustaining and then hiding a head injury so they could stay in the game. The ODH training teaches how to recognize signs and

symptoms of a concussion so, if any player exhibits a change in their behavior or appearance, they can be pulled from the game and questioned. If it is suspected they did sustain a head injury they would be placed on concussion protocol for the players safety. They would be required to be examined by a physician for clearance before returning to future play. The ODH also provides a Parental Information Sheet that explains what a concussion is and helps parents recognize signs and symptoms in case a coach or referee does not spot an injured player. Parents may approach a coach or referee during play with their concerns about any player. Since Copley provides the venue for these teams, and to ensure all teams are in compliance with HB143 mandate, the Trustees passed a Resolution in 2013 that requires all team coaches and referees to provide proof of their ODH training before reservations may be accepted. With almost 9000 total baseball



and soccer players using Township fields in 2021 (342 baseball reservations and 189 soccer reservations scheduled) the odds are one or more of these players will sustain a head injury. Safety of all players is paramount. Copies of the Resolution and Parental Information Sheets are available upon request or on the Township website.

that retain standing water in order to reduce mosquito and other insects from nesting, which can create an increased nuisance.

Foundations, floors, walls, ceilings, and roofs of every structure shall be properly constructed and maintained, and shall be kept in good repair and in safe condition, so as to make all occupied rooms and other interior areas weather-tight, water-tight, rodent-proof, fit for human habitation, and kept so as not to adversely affect the neighborhood in which they are located. Junk, including Inoperable or Junk Motor Vehicles shall not be maintained on private property unless such vehicle, junk, is stored within a completely enclosed permanent structure. Enclosed permanent structures do not include tarps, tents, or temporary carports with canvas tops. Large metal containers, enclosed truck beds, shipping containers, and other similar items are not permitted to be used as an accessory building.

Safety Town 2021


The Copley Township Safety Forces will be conducting our annual Safety Town School this summer, which provides needed training for the kindergarten child. Due to the recent pandemic, we will have a VIRTUAL Safety Town School and IN-PERSON Safety Town! You can only choose one for your child. Everyone attending in-person Safety Town will be required to wear masks including all volunteers. We will follow all CDC guidelines and take the children outside when possible!

Safety Town is a five-day summer educational program for children who will be entering kindergarten in the fall. The children are provided instruction in a wide assortment of safety topics. A simulated village is used to teach children most important pedestrian and bicycle safety rules. The village is constructed of miniature buildings, streets, and traffic signals and signs. In addition, children view videos, listen to speakers from several different safety agencies, and check out a school bus. The serious subject of safety is combined with craft activities, songs, videos and lots of fun.

The 2021 Copley Safety Town School will be conducted Monday, June 7 - Friday, June 11, 2021 at Copley-Fairlawn Middle School, 1531 South Cleveland-Massillon Road. There will be two time sessions, from 9:15 A.M. to 11:15 A.M. and from 1:15 P.M. to 3:15 P.M. Parents are to pick the time session of their preference; however, **the morning session does tend to reach capacity quickly.** Typically, the afternoon class is a smaller class size (and usually less hectic!) Registration will

be limited to the first 100 participants. Safety Town is open to children living in Copley Township or within the Copley-Fairlawn City School District who will be starting kindergarten in the fall. Students from Spring Garden Waldorf School that are not Copley residents may attend in the afternoon session. There are no exceptions to this requirement due to space and equipment restrictions. Proof of residency may be requested. Fairlawn residents are encouraged to attend Fairlawn Safety Town.

You may register your child for Safety Town School by completing the registration form that is available on the Copley Township website, www.copley.oh.us, or in the lobby of the Copley Police Department and Copley Town Hall. Severe Weather Alert!!

It's that time of year once again...news alerts of severe weather flash across the screen, the tornado sirens go off and everyone thinks...is this for real? Should I be worried and take these warnings seriously? The answer? Yes...and here are some helpful tools to get you ready!

- Tornado warning signs include seeing a funnel cloud, hearing a loud roar and noticing a change in the sky color; lightning and hail are also common in tornado weather
- Best protective location is a safe room or shelter. Get to a sturdy building with a small, interior, windowless room at the lowest level – a basement is best
- Practice moving quickly to a protective location in the places where you spend a lot of time
- Be prepared for power outages by gathering supplies for each household member
- Take time now to safeguard critical documents and take pictures or videos of your belongings
