The Land Use Plan Committee has been working diligently to finalize the document that will be used as the basis for development in Copley for the next 10 years. The Committee has spent the last several meetings fine tuning the Goals & Initiatives that have been identified throughout the 18-month process.

The Land Use Committee has scheduled 2 meetings to further discuss the Goals & Initiatives, after which the completed document will be recommended to the Board of Trustees for adoption.

This document is a critical component to the Township's future in that it will help guide development decisions, support the Township's position in any future litigation and become the basis for the re-writing of the Zoning Resolution which was started approximately 4 months ago.

The Committee strongly encourages the public to get involved in the Land Use Plan by:


- Attending the meeting on January 29th at 6:00 p.m. at Copley Town Hall

## Where Do Your Property Taxes Go?

If you are interested in how your tax dollars are spent, there is a new feature on the Summit County website that will tell you exactly how your tax dollars are distributed.

Go to [www.summitoh.net](http://www.summitoh.net), click on GIS Geographic Information, click on Tax Map and then Parcel Search and enter your address and street name. (Do not include road, circle or lane.)

When the parcel information box appears, click on View Property Card. Go to the bottom of the property card and click on 2007. Half way down the page click on "WHERE DO MY TAX DOLLARS GO".



You will see the Full Year Distribution Details for Tax Year 2007/Collection Year 2008.

### Homestead Exemption Program 2009

Summit County Fiscal Officer John A. Donofrio is reminding senior homeowners the State Legislature has expanded the Homestead Exemption Program, a reduction in property taxes, for all senior citizens 65 years or older or permanently and totally disabled under the age of 65.

Every qualified homeowner will receive an exemption of \$25,000 on the appraised value of their home from property taxes on a single family residence, regardless of their income.

Applications are available beginning January 5, 2009 until June 1, 2009 at [www.co.summit.oh.us/fiscaloffice](http://www.co.summit.oh.us/fiscaloffice) or at Copley Town Hall, 1540 S Cleve-Mass. Rd.

Homeowners who currently receive the Homestead reduction do not have to reapply.
