The Copley Homeowner's Association is Back!

From its formation in the 1970's, the Copley Homeowner's Association (CHA) played a big part in shaping the land use in Copley Township. Today a new group of Copley residents are picking up where the original founders left off. The Copley Homeowners Association is reorganizing - An organizational meeting will be held at the Copley Community Center at 7:00 p.m. on Thursday, January 19, 2012.

In the past, Copley Homeowner's Association focused on zoning, land use, and township services. Today, concerns are still the same. As in the past, Copley Township is once again being solicited for oil and gas leases. Not since the 80's has oil and gas been in such demand in Copley.

Just as in the Gold Rush of 1849, there is currently a rush to seek riches beneath the ground, not in California but Copley, Ohio. Today the "gold" is in the form of oil and gas deposits as deep as two miles beneath the surface. Just as in 1849, there are substantial opportunities and risks to be faced and overcome by those seeking these riches. Welcome, the Oil and Gas Rush of 2012.

This rush for exploration and extraction of oil and gas deposits has been ongoing for a number of years to the east in Pennsylvania, New York and West Virginia. Within the last 18 months the search has moved into eastern and southeastern Ohio. Within the last month or two the quest has moved into Summit County. Many local landowners have been solicited by out of state companies seeking to acquire their "mineral rights".

The first goal of the "new" edition of the Copley Homeowner's Association will be to provide a forum to insure that the public is made aware of FACTS. The goal is to provide the public a forum to gather and discuss the positive and potentially negative aspects of oil and gas extraction. The intent is to bring in experts and spokespersons representing all viewpoints. In all likelihood there will be a wide range of opinions. Without a doubt there will be those who will resist all efforts to explore and extract the oil and gas locally and there will be others who are ready and willing to move in that direction immediately. In all probability, the majority of landowners will not know enough to form an opinion.

When Caught In A Winter Storm

<u>Outside</u>	<u>In A Vehicle</u>	<u>Inside</u>
<ul style="list-style-type: none"> Find shelter to stay dry and cover all exposed body parts. 	<ul style="list-style-type: none"> Stay in vehicle. You will become quickly disoriented in wind-driven snow and cold. Run the motor about 10 minutes each hour for heat. Open the window a little for fresh air to avoid carbon monoxide poisoning. Make sure the exhaust pipe is not blocked. 	<ul style="list-style-type: none"> Stay Inside When using alternate heat from a fireplace, wood stove, space heater, etc., use fire safeguards and properly ventilate.
No Shelter <ul style="list-style-type: none"> Build a lean-to, windbreak or snow cave for protection from the wind. Build a fire for heat and to attract attention. Place rocks around the fire to absorb and reflect heat. 		No Heat <ul style="list-style-type: none"> Close off unneeded rooms. Stuff towels or rags in cracks under doors. Cover windows at night. Eat and drink. Food provides the body with energy for producing its own heat. Keep the body replenished with fluids to prevent dehydration. Wear layers of loose-fitting, lightweight, warm clothing. Remove layers to avoid overheating, perspiration and subsequent chill.
Melt snow for drinking water <ul style="list-style-type: none"> Eating snow will lower your body temperature. 	Be Visible To Rescuers <ul style="list-style-type: none"> Turn on the dome light at night when running the engine. Tie a colored cloth, preferably red, to your antenna or door. After snow stops falling, raise the hood to indicate you need help. Exercise <ul style="list-style-type: none"> From time to time, move arms, legs, fingers and toes vigorously to keep blood circulating and to keep warm. 	

AVOID OVEREXERTION, such as shoveling heavy snow, pushing a car or walking in deep snow.

The strain from the cold and the hard labor may cause a heart attack. Sweating could lead to a chill and hypothermia. Take Red Cross Cardiopulmonary Rescue (CPR) and Automated External Defibrillator (AED) training so you can respond quickly to an emergency.

Cemetery Survey

At the November 2, 2011 Board of Trustees meeting, a discussion was opened concerning the future of the Copley Township Cemetery and the future of offering cemetery services. The Board was informed that the number of currently available burial lots was diminishing and it was only a question of time before there would no longer be any burial lots left. The question raised was whether Copley Township wishes to continue offering cemetery services in the future and, if so, by what means can that be accomplished?

The Copley Township Cemetery was founded in 1820 and has been active for 191 years. It is remarkable that after all those many years, the cemetery still has burial lots available. This is due to the fact that decades ago, a past Board of Trustees had the foresight to establish a policy that burial lots can be purchased only at the time of need, no additional lots may be reserved, and the lots are to be sold in numeric order per Section, depending on the family's need. If not for that policy, the cemetery most likely would have been sold out years ago.

In its present configuration, the cemetery contains 1829 burial lots in nine different sections. As of this writing, there are roughly 125 total burial lots available. Burial lots contain one, two, or three graves per lot. Copley Township, on average, performs 25-30 burials per year. It is estimated that in 4 years there will be no single grave lots left and in 16 years, no double or triple grave lots left.

The estimated yearly expiration dates are based on the average number of new lots sold in the last 5 years per Section. The Township realizes that it will not be able to perpetually have burial lots available for all time and, eventually, at some point in the Township's future history, all cemetery services will cease. Future generations of Copley officials will be charged with the maintenance of these sacred grounds.

Although it may appear there is ample time to decide the future of offering cemetery services, the time to decide that future is before us and should not be delayed, thus the reason for conducting this survey. The Copley Board of Trustees highly values its resident's input on all matters and this survey will assist them in their decision making process for the future of the Copley Township Cemetery. Your input is greatly appreciated. Please take a few minutes of your time and answer the questions in the survey on p.4-5 and return it in person, by mail or by fax.

Copley Stands Strong Together

After the 8-7-11 tragedy, reader boards at businesses throughout Copley Township proudly proclaimed "Copley Stands Strong Together." In an effort to continue this display of solidarity, available beginning Tuesday, December 20, will be bright yellow 24"x 24" yard signs with that slogan printed in dark blue. Across the top of the sign are seven people holding hands that remind us of the victims of the tragedy. The signs are being sold for \$10 each, including the stake. The yard signs are made to last for years. They will be available for sale during normal business hours at Copley Town Hall, 1540 S. Cleveland-Massillon Road and at Designer League located on Copley Circle. This project has been spearheaded by Healthy Communities Healthy Youth Copley-Fairlawn. Signs are being sold at cost, this is not a fundraiser.



Free Income Tax Preparation

The American Association of Retired Persons (AARP) through its Tax Aide Program, offers free assistance in preparing personal income tax returns for persons ages 60 and older in the middle to low income tax brackets. The Tax-Aide Program is a charitable, non-profit program administered by the AARP Foundation in cooperation with the Internal Revenue Service. Locations that are convenient for Copley residents are the Fairlawn/Bath Library, Norton Library and Barberton Library. Appointments are necessary and be sure to gather all required information before you go. A photo ID and your original social security card are required along with a letter from Social Security Administration or your SSA-1099 benefit statement. It is always helpful to have a copy of your last year's return.
