Copley Fairlawn Cares Backpack Program Spring - Summer 2020 Summary

Copley-Fairlawn Cares is a non-profit, volunteer organization in cooperation with the Copley Outreach Center that addresses food insecurity in children in the Copley-Fairlawn City Schools. The original plan for the program was to roll out the Summer Lunch Box Program as soon as school ended in June 2020. Due to the pandemic, the program started early and it is still going strong.

The Outreach Center planned on keeping the weekly program going until the students were back in school and then re-evaluate.

The students were able to pick up a large box of food every week at the Copley Outreach Center on Tuesdays and Fridays from 10:00am to 2:00pm. With the help of the Copley-Fairlawn Kiwanis,

the Outreach Center delivered every Tuesday to 19 students.

The Outreach Center has had an outpouring of donations from the community over the last five months. One of their main goals is to make sure the community knows about the program and how they can help. The following is a breakdown of how many student food boxes were distributed.

Senior Snowplow Program


The Board of Trustees has approved another season of the Senior Snowplow Program. This will be the 13th year of this well-received service. If you are 65 years of age and/or handicapped, and there is no other person residing in your home that is physically capable of removing snow, then you may qualify for this program. Inspecting Your Mailbox

With Old Man Winter lurking around the corner it is time to once again inspect your mailbox and post to see if it needs any repairs. Check the post to make sure it is sturdy and not rotted or rusted through. Check the box to see if the door shuts properly and the flag stays standing. Check the mounting bolts/screws and replace any that have rusted or broken off. Doing this inspection now saves you from having to do it in the bitter cold and ensures your mailbox is ready for the brutal conditions. The Township is NOT responsible for damage to a mailbox/post due to the weight of the snow as it curls off the plow. The Township will repair/replace the mailbox/post if the plow actually strikes the mailbox/post.

Copley Community Park Rules

A friendly reminder to park users that bicycles are not permitted on the trails. This is to prevent walkers from being struck by riders along the narrow winding paths that are not designated for shared-use. In addition, we remind you that all dogs are to be kept on a leash no longer than 8' at all times and it is advisable to bring your pet close to you when approaching other park users. All dog owners are responsible for any actions of their pets and owners are to clean up after their pet. Dog waste stations are placed in convenient locations for their use.

What Can We Do For You?

CPR Classes - We offer two types of American Heart certified CPR courses, Heart-saver/AED or Healthcare Provider courses. The cost of the class is \$25.00 for Heart Saver per person and \$30.00 for Healthcare Provider. Minimum class size is 5.

Car Seat Installation - We have certified car seat installation technicians available to answer your questions and help assist you with installing your child safety seat properly.

Fire Safety Training - Training in proper use of fire extinguishers, fire safety lectures for businesses, healthcare providers and offices.

Fire Extinguishers - Learn how to properly use a fire extinguisher with live props and simulated fire. Get hands on with a real fire extinguisher and practice basic use in a controlled setting. Minimum class size of 10.

Residential Knox Box Program - Our Residential Knox Box Program offers special key boxes for our residents with special needs. A set of keys to access your residence is stored inside the box, which can only be opened with a special key stored securely in our fire vehicles and ambulances. This allows the Fire Department to enter your home in case of emergency without causing any property damage.



Home Safety Planning - If you have concerns with fire safety, we would be glad to come and inspect your house for fire safety issues. During our visit we will answer any questions you may have and provide important information on how you can make your home a safer place to live.

Smoke Detectors - Every house needs working smoke detectors. Don't have one, don't worry. We will connect you with our American Red Cross partners to have smoke detectors installed in your home.

First Aid/Stop the Bleed - We provide instructors to teach basic first aid. We also have certified instructors to teach the nationwide Stop the Bleed program. Cost for the first aid class is \$35.00 per person.

Fire Station Tours - We offer fire station tours for child groups. This gives everyone a chance to see up close and personal all the equipment and where firefighters live for 24 hours. Maximum group size is 20. Adequate adult supervision must be provided.

Citizens Fire Academy - Ever wonder what it would be like to be a firefighter? Here is your chance! Our biannual academy puts you in the shoes of our firefighters learning everything from emergency medical skills to firefighting tactics.


Bike and Pedestrian Planning Takes Shape

POTENTIAL MULTI-MODAL ROUTES

The Copley Township Board of Trustees, in consultation with Environmental Design Group, is in the process of developing capital improvement plans for active transportation facilities. This is a multi-modal connectivity plan highlighting off-road and on-road facilities throughout the Township. The facilities will include bike lanes, sidewalks, sidepaths, and even updated signage. This is all done in an effort to increase connectivity between neighborhoods and attractions in all four quadrants of the Township.

The plan itself will guide planning decisions for both private and publicly funded infrastructure projects.

Identifying the type and location of improvement will position the Township to apply and receive funding for future construction. We welcome feedback, and feel free to share, comment, and help spread the word on the importance of this document and these amenities to Copley Township. Keep in mind, this is still in draft form, and the elements within this document are simply recommendations at this time. 
Each food box contained:

Non-perishables: Spaghetti noodles, pasta sauce, rice, ramen noodles, chicken noodle soup, corn, green beans, Spaghetti Os, beef ravioli, nuts, peanut butter and jelly, protein bars, cereal, pop tarts, fruit cups, juice boxes, crackers, mac n cheese, oatmeal, cookies, chips.

Perishables: Chicken nuggets, chicken breasts, bologna, hot dogs, eggs, squash, zucchini, apples, frozen pizza, deli meats, hot dog buns, hamburger buns, and loaves of bread.

Hygiene Products: Shampoo, conditioner, liquid and bar soaps, dish soap, laundry soap, toothpaste, toothbrush and deodorant.

- In 2009, EnviroScience conducted an Environmental Inventory for Copley Township and concluded that approximately 83% of the land was environmentally sensitive.
- Environmental issues which impact Copley Township include flooding of the southeast quadrant known as "Little Farms" and limited centralized resources including sewer and water.
- Wetlands serve as natural infrastructure effective for flood abatement. A one acre wetland can store about one million gallons of water.
- Wetlands serve as natural filter for waters leading to public drinking sources.
- Wetlands are protected federally under the Clean Water Act 404, Swampbuster Act, Environmental Protection Agency, Army Corp of Engineers.
- They are also protected State and locally under the OHEPA, Soil & Water Conservation District and by the Copley Township Zoning Resolution.

Wetlands Overview

What Is a Wetland?

Although wetlands are often wet, a wetland might not be wet year-round. In fact, some of the most important wetlands are only seasonally wet. Wetlands are the link between the land and the water. They are transition zones where the flow of water, the cycling of nutrients, and the energy of the sun meet to produce a unique ecosystem characterized by hydrology, soils, and vegetation—making these areas very important features of a watershed. Using a watershed-based approach to wetland protection ensures that the whole system, including land, air, and water resources, is protected.


Did You Know? Township Limited Home Rule

PART 2 ADOPTING LIMITED HOME RULE

The process to adopt Limited Home Rule in Copley Township is detailed in the Ohio Revised Code, Chapter 504.01, Sections 3 and 4. Because the population of the Township exceeds 15,000, the Board of Trustees, after holding at least one public hearing, may do either of the following:

1. By a unanimous vote, adopt a Resolution establishing Limited Home Rule. That Resolution would become effective 30 days after the date of its adoption unless a petition signed by a number of registered electors equal to at least 10% of the total votes cast for all candidates for governor at the most recent general election at which a governor was elected. The petition would request that the question be placed on a ballot at the next primary or general election that occurs at least 90 days after the petition is submitted.
2. By a majority vote, adopt a Resolution requesting the Board of Elections to place the question on the ballot at the next general election that occurs at least 90 days after certification of the resolution to the Board of Elections.

The Ohio Revised Code also provides a process by which the registered electors of the Township may petition the Board of Trustees to adopt a Resolution requesting



the Board of Elections to place the question on the ballot by submitting a petition signed by a number of registered electors equal to at least 10% of the total votes cast for all candidates for governor at the most recent general election at which a governor was elected. The question would then be placed on the ballot of the next general election that occurs at least 90 days after the certification of the Resolution to the Board of Elections.

While it may seem complicated, the process for Copley Township to adopt Limited Home Rule is actually quite simple and provides a forum for Township residents to voice their opinions. The Township's goal is to fully inform residents on the many positive aspects of becoming a Home Rule Township offering full transparency of the entire process.
