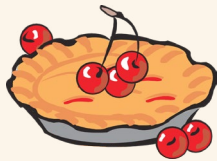

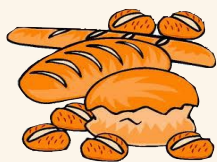

Change Your Clocks, Change Your Batteries

If your smoke detectors are wired into your electrical system, they may have batteries as a backup in case there is a power failure. Be sure to change the batteries in these detectors as well.

Fire Department Activity

Portable Generators Are Helpful, May Also Be Harmful

Many residents of Copley own and operate portable generators when their power is out. Your fire department wants to stress the proper use of portable generators is important for the safety of you and your family. According to a recent study by the National Institute of Standards and Technology (NIST) operating a portable generator "indoors or close to open windows, doors or vents" has resulted in more than 500 deaths in the last 8 years. The most vulnerable are our residents 65 years or older.

According to NIST, the exhaust of a portable generator produces carbon monoxide "at a rate of 500 to 4000 grams per hour." You do not want that deadly and colorless, odorless gas entering your home. The Copley Fire Department recommends following the manufacturer's instructions when operating a portable generator and these tips from the United States Fire Administration:

- Always use generators outdoors, away from doors, windows and vents.
- NEVER use generators in homes, garages, basements, crawl spaces or other enclosed or partially enclosed areas, even with ventilation.
- Install battery-operated or plug-in (with battery backup) carbon monoxide (CO) alarms in your home, following manufacturer's instructions.
- Test CO alarms often and replace batteries when needed.
- Never plug the generator into a wall outlet. This practice, known as backfeeding, can cause an electrocution risk to utility workers and others served by the same utility transformer.
- If necessary to connect generator to house wiring to power appliances, have a qualified electrician install appropriate equipment. Or, your utility company may be able to install an appropriate transfer switch.

Winter Safety Tips For Your Home

Water heaters, furnaces and boilers need air to operate safely, otherwise they will produce deadly carbon monoxide. Carbon monoxide is odorless and colorless, and that means you can't see, taste or smell it.

The initial symptoms of CO poisoning are similar to the flu (but without fever). They may include:

- Headache
- Fatigue
- Shortness of Breath
- Nausea
- Dizziness



Proper installation, operation and maintenance of fuel-burning appliances in the home is the most important factor in reducing the risk of CO poisoning. Look for problems that could indicate improper appliance operations:

- Decreased hot water supply
- Furnace unable to heat house or runs continuously
- Sooting, especially on appliances and vents
- Unfamiliar or burning odor
- Increased moisture inside of windows



Service Department Activity

Septic System Inspections

In an effort for Copley Township to be in compliance with Ohio EPA Phase II Illicit Discharge Detection & Elimination Regulations, the Summit County Health Department (SCHD) has been inspecting waste water discharges from septic systems throughout the township. This is done by taking a sample of the waste water from where it exits the system and taking it to a lab for testing to see if it falls within mandated EPA acceptable limits. In many cases, there is no access to the discharge location and no sample can be obtained. In those situations, the SCHD has been ordering property owners to install an inspection port so the inspectors have the required access. In some older allotments, and because of the design of the septic systems of that time period, discharge lines can be buried very deep in the ground. In order for these systems to drain properly, common septic lines were installed by the home builders in which several individual homeowner systems were tied into and discharge at a single location. Questions have arisen as to who would be responsible for the maintenance and repair of these common septic lines and the answer is the property owners whose septic systems they serve. Copley Township is only responsible for maintaining roadside storm water drainage systems to protect the road base and not private septic systems.

Senior Snowplow Program

The Board of Trustees has again approved the continuation of the Senior Snowplow Program for our elderly and/or disabled residents. Qualified participants who cannot or should not shovel snow from their driveways have appreciated this service since its inception in the 2007-2008 winter season. Copley Service Department

Some people don't want to think of winter yet, but the Service Department has to in order to be fully prepared for the impending weather. The plow trucks, plows both large and small, salt spreaders, front end loaders, and pickup trucks will soon be ready for the first sign of snow. The Township has approximately 1000 tons of salt on hand to start the season and another 2900 tons is available through CUE membership contracts.

Winter Reminders

- Check your mailbox to make sure it is sturdy or needs repairs. The township is not responsible for mailboxes knocked down by heavy snow or slush.
- Use only flexible markers to mark the edge of your yard by the road. Rigid markers, poles or any solid object will be removed.
- Refrain from placing garbage cans in the road.
- Do not park in cul-de-sacs.
- Do not shovel, blow or plow snow into the road. This creates a road hazard. Homeowners and snowplow contractors should be aware they can be cited for placing obstructions, including snow, on the roadway.
- Do not plow snow across the road. Snow from your driveway should be kept on your property.
- Never let your children play on or in large piles of snow by the roadway. Plow drivers may not see them when pushing snow and tunnels can collapse and bury the kids.
- Slow down when approaching a snow plow. The plow driver is very busy inside the cab. You may see him but the plow driver may not see you.

Community Activity

Bath and Copley Townships received a study grant for \$50,000 from the Akron Metropolitan Area Transportation Study (AMATS) to improve accessibility in the Montrose area that is in both townships' jurisdiction. The plan is to study the feasibility of making the area intermodal for pedestrians, cyclists, bus-riders and motorists. In addition, the study should aid the townships in how to "soften" Montrose with a sense of community via visual aesthetics.

The consulting company hired to conduct the study is Environmental Design Group (EDG). There will be several meetings with the businesses in Montrose as well as public forums for everyone to attend.
