Board of Trustees - 2026 Meeting Schedule

During the regular meeting on December 22, 2025, the Copley Township Board of Trustees approved the meeting schedule for 2026. All meetings will take place at Copley Town Hall, located at 1540 S. Cleveland Massillon Road in the North Room. Meetings are open to the public and will be streamed live on the Township website at copley.oh.us.

While the meeting schedule is set for the year ahead, 2026 will bring several changes in Township leadership. Copley Township has experienced notable transitions leading into the new year, beginning with the retirement of Township Administrator Janice Marshall, effective February 1, 2026. Ms. Marshall served the Township for more than 20 years, first in the Fiscal Office and most recently as Township Administrator. Her commitment and years of service have made a lasting impact to the community and her contributions are greatly appreciated.

Following a search process, the Board of Trustees appointed Greg Tracy as the new Township Administrator. Mr. Tracy previously served as Service and Development Director, where he oversaw the Service Department as well as the Community and Economic Development Department.

Additionally, the Board of Trustees also approved new hires, including Kristen Light, Accounting Clerk; Megan Sutherland, Community Development Coordinator; and are in the process for an Administrative Assistant in the Service Department. The Board also announced promotions for various Township personnel, which are highlighted within each department section of this newsletter.



Architectural Design Guidelines

The Copley Township Architectural Review Board is working to establish design guidelines for new commercial, mixed use, industrial and subdivision development in the Township. As a Township, Copley is not permitted to require architectural design or aesthetics above and beyond the Zoning Resolution in areas outside of a zoned historic district. The Guidelines will be compatible with zoning regulations and will assist the Township in communicating the goals and desires for the look and feel of development. In general, the Guidelines will work to promote high quality development in the areas of: Site Planning, Architecture, Landscape and Tree Preservation, Lighting and Signage. The Guidelines will be reviewed at monthly meetings of the Architectural Review Board (ARB). The ARB meets the first Monday of each month at 6:00 pm. Zoning Resolution Audit

The Copley Township Zoning Commission is in the process of conducting a Zoning Resolution Audit. The current Zoning Resolution was adopted in 2012. Since this time, incremental updates have been completed to reflect desires of the Township and updates to the Ohio Revised Code. It is suggested that a Zoning Resolution undergo an audit/update every 5-10 years in conjunction with a Comprehensive Land Use Plan review and update. The Audit will assist the Township in ensuring:

- Alignment with the adopted Copley Township Comprehensive Land Use Plan
- Streamlined zoning procedures to facilitate high-quality development
- Modernized definitions and permitted uses
- Improved clarity and usability for the public, developers, and staff
- Compliance with Ohio Revised Code Section 519.

Changes recommended by the Audit will be presented during regular business meetings of the Zoning Commission. The Commission meets the first Thursday of each month at 6:00 pm. For more information, please visit <https://www.copley.oh.us/176/Zoning-Commission>

Don't Crowd the Plow

As winter weather continues, residents are reminded to give snow plow trucks plenty of space while traveling the roadways. These five-ton vehicles are responsible for maintaining more than 64 miles of roads, working to ensure safe travel for Copley residents, employees, and students.

For everyone's safety, please avoid following plow trucks too closely and use extra caution when approaching or passing them. Allowing plow operators the room they need helps keep roads clear and protects both drivers and Township employees during winter weather events.



Check your Mail... Box

Speaking of winter weather, now is the perfect time to make sure your mailbox is in good condition and able to withstand snow removal operations! Mailboxes should be securely installed and free of deterioration, such as rotted wood or corroded fasteners. If the structural integrity of a mailbox is compromised, it may be damaged by the weight of snow being pushed from the roadway during plowing.

If a mailbox is directly struck by a township snowplow, the Township will coordinate its repair. However, damage caused by snow being thrown from the plow is the responsibility of the property owner. If you believe your mailbox was directly hit by a snowplow, please contact the Service Department by calling (330) 666-0365.

Fire Department

Preparing for a Safe Spring

With spring, around the corner it's not too early to think about the next season approaching and related fire safety priorities. As you begin your spring cleaning and prepare your yards for the warmer months, I ask you to keep these vital safety tips in mind to protect your family and our community.

1. The "Spring Forward" Life-Saver

While we have moved away from the need to change clocks manually on every device, the tradition of checking your smoke alarms remains critical.

- Test every alarm: Ensure there is a working smoke detector on every level of your home and near all sleeping areas.
- Replace batteries: If your alarms are not the 10-year sealed battery type, now is the time to put in fresh ones.
- Check the date: Smoke alarms expire every 10 years. If yours are older, it's time for a replacement.

2. Spring Cleaning Beyond the Dust

Spring cleaning is the perfect opportunity to eliminate hidden fire hazards inside your home:

- Dryer Vents: Lint buildup is a leading cause of home fires. Beyond cleaning the lint trap after every load, take the time this spring to inspect and clean the entire exhaust duct.

- Clutter Clearance: Clear out stacks of old newspapers, rags, or flammable liquids stored near furnaces or water heaters.

3. Safe Outdoor Living

As we move our cooking and cleanup outdoors, please be mindful of Ohio's seasonal regulations:

- Grill Readiness: Before your first cookout, inspect your grill for leaks or cracks in the hoses. Keep grills at least 10 feet away from your siding and eaves.
- Open Burning Ban: Remember that Ohio State law prohibits most outdoor burning in unincorporated areas from 6:00 AM to 6:00 PM during March, April, and May. This is due to the high risk of wildfires caused by dry vegetation and spring winds.

4. Help Us Find You

In an emergency, every second counts. Please ensure your house number is clearly visible from the street. If your numbers are faded or hidden by new spring growth, please take a moment to trim the brush or refresh the paint. Our team at the Copley Fire Department is honored to serve this township. Whether we are operating out of our New Safety Center or responding to a call on your street, our goal is your safety. Let's work together to make this a safe and vibrant spring season.

Copley and Revere PBIS

Copley-Fairlawn City Schools and Revere Local Schools continue to support students through the Positive Behavior Interventions and Supports (PBIS) framework. PBIS is a school wide approach that focuses on promoting positive behavior, helping students succeed both academically and socially. Both school districts implement PBIS in age-appropriate ways, using incentives, recognition programs, and consistent expectations to reinforce positive choices. By focusing on prevention and early support, PBIS helps students build essential life skills that contribute to a safe, welcoming school environment. While both districts are pioneering this proactive system for education, their methods differ slightly.

Revere High School has recently been awarded a Bronze level distinction for its PBIS program and is actively working toward district wide recognition for its efforts. Revere High School and Revere Middle School utilize an additional PBIS guide uniquely known as the "Vision of a Minuteman." Each month, educators submit nominations for students to attend "Momentum Meals." During these celebrations, students can collect merchandise from the "Swaggin Wagon," play for prizes using a claw machine, and redeem rewards for snacks, swag and more!

Copley Fairlawn City Schools continue to demonstrate a strong commitment to PBIS implementation and student support across the district. Herberich Primary School has earned a Silver Distinction, and Copley Fairlawn Middle School has received a Bronze Distinction in recognition of their efforts. These distinctions highlight the daily work of educators and staff who implement this framework. Earlier this January, Copley-Fairlawn Middle School celebrated their students' success with their quarterly PBIS incentive. Lisa McFedries, Dean of Students, told us that "Approximately 92% of students received an invite, meaning they received zero consequences across all school settings for the previous quarter; it was a huge success!" Copley Township is proud to support initiatives that strengthen our schools and provide a positive educational experience for families throughout our community.

Soup Sale for Veterans

The Copley American Legion Auxiliary Unit 473 will have a soup sale on Saturday, February 7 from Noon to 4:00 p.m. at the Copley American Legion Frank Bender Post 473, 3255 Copley Road. A variety of homemade soups will be offered: \$10 for a quart to go, and only \$5 to enjoy a bowl at the post. Stock up for the big game!

Copley Outreach Center

Copley Outreach would like to thank all of our community members, churches, and businesses who have continued to support our mission to end hunger in our schools



and community. This year has been challenging, but with community support, we have been able to feed more families and their children than ever before! This year, we have distributed 1444 bags of groceries to 450 households, 4320 weekend bags to 120 students during the school year, and 85 weekly boxes to 40 students throughout the summer. To continue providing food assistance to community members in need, we rely on your generosity through donations. This year, we have spent over \$18,000 on food from Aldi's, Sam's Club, and the Akron-Canton Food Bank. Your support, whether through food donations or monetary contributions, is highly valued as we work to address food

insecurity. Copley Township has 3,613 households, and Fairlawn has 3,577, for a total of 7,190 households in our service area. If 200 of these

households committed to donating \$15.00 per month to Copley Outreach, we would receive \$3,000 per month, or \$36,000 per year! This would cover the cost of all our food and the supplies needed to provide for these families for an entire year.
