RESOLUTION NO. 5 -2011

AN AMENDMENT TO RESOLUTION 2003-08 ESTABLISHING THE RULES AND REGULATIONS FOR COPLEY COMMUNITY PARK, TO INSTITUTE BUSINESS RENTAL FEES, RULES AND REGULATIONS FOR RENTAL OF PARK PAVILIONS BY BUSINESSES

WHEREAS, Copley Township Service Director has requested to establish business rates, rules, and regulations for businesses renting pavilions at the Copley Community Park, and;

WHEREAS, the current pavilion rental fee, rules and regulations schedule does not indicate rates, rules, or regulations for a business to rent a pavilion, and;

WHEREAS, business rentals can be attended by a large group of people, and;

WHEREAS, The Copley Township Board of Trustees desires to establish a business rate, rules, and regulations for pavilion rentals.

NOW, THEREFORE, BE IT RESOLVED that the Copley Township Board of Trustees hereby establish the following fee schedule, rules, and regulations pertaining to business pavilion rentals;

1. Copley Township hereby sets forth the following rental fees for businesses requesting to rent a pavilion at Copley Community Park
 - a. Businesses located within the Copley Township limits \$100 per pavilion
 - b. Businesses located outside of the Copley Township limits \$150 per pavilion
 - c. The business rental rate will apply regardless of the residential status of the owner or employee of the company requesting the rental.
 - d. Capacity of pavilions are not to exceed 80 persons per pavilion. Reservations expecting more than 80 persons will be required to rent 1 pavilion for every 80 people.
 - e. The payment procedure for business rentals will remain the same as the standard rental procedure.
 - f. All other rules and regulations pertaining to pavilion rentals will apply to business rental.
2. It is found and determined that all formal actions by the Board of Township Trustees concerning and relating to the adoption of this Amendment to the Resolution were adopted in an open meeting of the Board of Township Trustees and that all deliberations of the Board of Township Trustees, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.
3. This Resolution shall take effect upon adoption.
