ARTICLES OF INCORPORATION
OF
COPLEY HOMEOWNERS ASSOCIATION, INC.

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under the General Corporation Law of Ohio (Revised Code Sections 1702.01 et seq.), do hereby certify:

FIRST. The name of said corporation shall be:

COPLEY HOMEOWNERS ASSOCIATION, INC.

SECOND. The place in Ohio where the principal office of the corporation is to be located is the Township of Copley, in Summit County.

THIRD. The purposes for which said corporation is formed are:

To promote the general welfare and well being of homeowners, families and residents within the Township of Copley, Summit County, Ohio or its successor political subdivision, by giving special attention to public improvements therein and all that relates to the betterment thereof, to land use and the planned and orderly development thereof, and zoning issues, to capital improvements therein constructed by civic and governmental groups, to foster pride and interest in governmental and civic functions, to assist in formulating issues of interest and concern to homeowners, families and residents located therein and disseminating information pertaining thereto, and to engage in such actions and activities as will benefit the homeowners, families and residents within the Township

of Copley, Summit County, Ohio; and the doing of any and all things necessary or incident thereto.

To levy dues upon members as may be provided in the Regulations of the corporation, by the authority and action of its board of trustees; to receive, collect and expend funds and moneys and to invest and re-invest the same.

To purchase, acquire, lease, exchange, and own, hold, invest in, develop, use and manage, encumber, sell, transfer and dispose of property of every kind and description, real, personal or mixed, and any interest or right therein, as may be provided in the Regulations of the corporation.

To perform and do all things, so far as permitted by law, necessary, proper and suitable for the accomplishment and attainment to the purposes and objectives hereinbefore set forth, either alone or in association with persons, firms, corporations or other associations or groups; and to do every other act or thing incidental to or connected with such purposes and objectives of this corporation, provided the same be not inconsistent with the laws under which this corporation is organized.
