All mobile food service vehicles must operate on commercially zoned property within the Township adhering to the following regulations:

1. Written permission from the property owner must be provided at the time of application for the Mobile Food Service license
2. Sufficient parking must be available on site to allow for safe pedestrian and vehicular traffic
3. A copy of the permit issued by the Summit County Public Health Department is required at time of application
4. The mobile food service vehicle must pass inspection from the Copley Township Fire Department
5. The mobile food service vendor must supply trash receptacles and dispose of the trash collected and/or liquids, by-products or waste generated by the operation at the end of each day; absolutely no dumping is allowed
6. No accessory structures are permitted including but not limited to picnic tables, chairs, benches
7. Mobile Food Service vendors may operate from 7:00AM – 11:00PM with permission from the property owner
8. The permit is valid for a total of 120 days from January 1 through December 31 with no more than 40 consecutive days in one location.
9. A fee of \$100.00 will be collected at the time of application for the entire calendar year

Mobile Food Service vendors that are hired to cater private events do not require a license, however, signs stating that the event is not open to the public must be clearly posted and advertisement of the event is not permitted.

Mobile Food Service vehicles are not permitted in residentially zoned areas in the Township unless providing private catering services.

Mobile Food Service vehicles are strictly prohibited from operating on public roadways unless permission has been granted by the Copley Township Police Department to close the road for a special event.

Mobile Food Service vendors invited to participate in Township sponsored events are not required to obtain a license.
