Dear Parents:

The Copley Township Safety Forces will be conducting our annual Safety Town School this summer, which provides needed training for the incoming kindergarten child. Safety Town School is a five-day summer educational program for children who will be entering kindergarten in the fall. The children are provided instruction in a wide assortment of safety topics. A simulated village is used to teach children important pedestrian and bicycle safety rules. The village is constructed of miniature buildings, streets, and traffic signals and signs. In addition, children view videos, listen to speakers from several different safety agencies, and ride a school bus. The serious subject of safety is combined with craft activities, songs, snacks and lots of fun.

The 2025 Copley Safety Town School will be conducted the week of June 16–20, 2025 at Copley-Fairlawn Middle School, 1531 South Cleveland-Massillon Road. There will be two time sessions, from 9:00 A.M. to 11:15 A.M. and from 1:00 P.M. to 3:15 P.M. Parents are to pick the time session of their preference; however, **the morning session does tend to reach capacity quickly.** Parents who register before **May 30th** should be assured the time slot of their preference. However, this depends upon the number of registrations received. After that, children may be assigned to sessions depending on class size. Typically the afternoon class is a smaller class size (and usually less hectic!) Registration will be limited to the first 100 participants. Safety Town is open to **Copley residents** that have children attending kindergarten in the Fall. Students from Spring Garden Waldorf School that are not Copley residents may attend in the afternoon session. There are no exceptions to this requirement due to space and equipment restrictions. Proof of residency may be requested. Fairlawn and Bath residents are encouraged to attend their community safety towns.

You may register your child for Safety Town School by completing the registration form provided and returning it to the Copley Police Department. You may also scan and email forms to safetytown@copley.oh.us. You will receive an email confirmation that your form has been received. No forms will be accepted after May 30th or earlier if the maximum number of participants is reached. Confirmations will be sent the week of June 2nd.

Student volunteers (over the age of 13) are needed. Application forms are available online and at the police department. Please email Windy Lewis at safetytown@copley.oh.us if you have further questions.
